Eligibility

- Existing licensed family day homes, voluntarily registered family day homes, local ordinance approved family day homes, unlicensed homes and centers that are approved subsidy vendors, licensed child day centers, religiously exempt child day centers, certified preschools, and licensed family day systems.
- Facilities must be open to provide care for children
- Facilities must follow COVID-19 health and safety guidelines

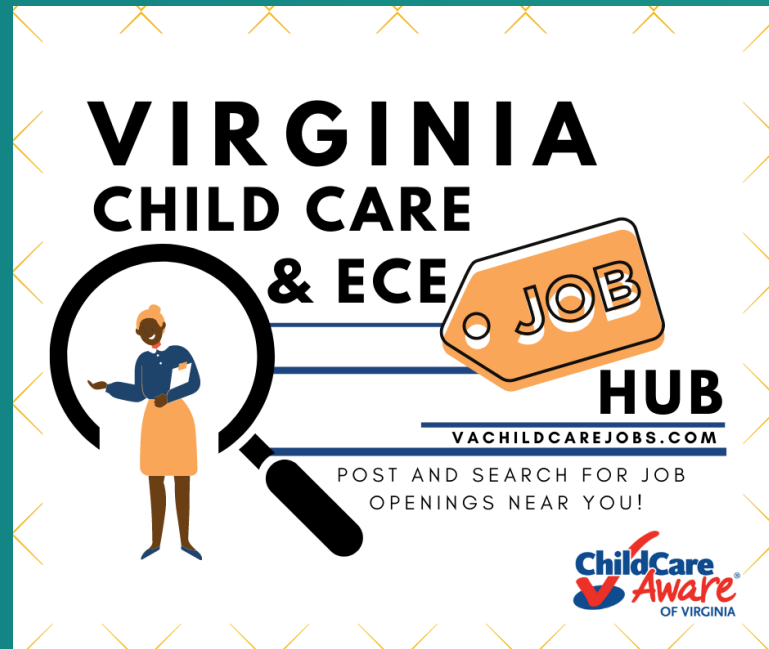
